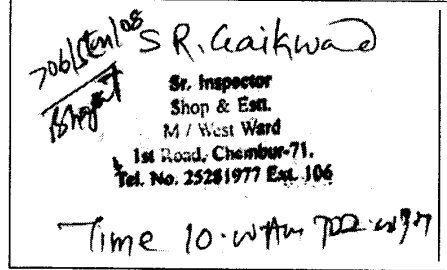

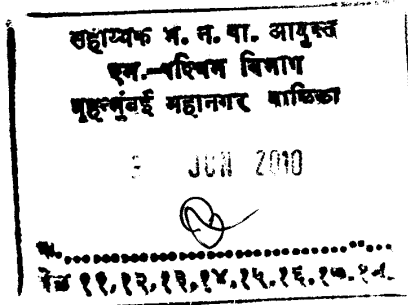
**Sub: Your visit to the premises of E-convergence Technologies Ltd**

Dear Sir:

This is in connection with your reported visit to the premises of E-convergence Technologies Limited (ETL) of which I am chief promoter, director and authorized signatory. I was told by a person who stands outside our building that you had visited our premises on Monday 21 June 2010, but on finding the premises locked, had left your card (reproduced above and as an attachment – A1). **The reason why the premises were locked is because ETL does not do any business any more as explained below.**

In this connection, I would like to submit as under:

1. I tried contacting you on the telephone number given on your card for two days, and since I could not reach you, I asked Mr. Santosh Bharati, who liaises for us with your office for payment of dues, to contact you and find out what the problem was.
2. I am told that he visited your office on Friday, 25th June, 2010, and that you had requested him to bring with him some details regarding payments ETL had made to your office under the provisions of the S&E Act.
3. I am told that he met your officers on Monday 28 June, 2010.
4. I am told that he informed you that all payments in respect of the S&E Act had been made and had submitted copies to you in this connection. For purposes of record and ready reference, I am attaching copies of the documents relating to 2005-06 (A-2), 2006-07(as court fee receipt – A-3), 2008-09 (A-4) and 2009 to 2012 (A-5).
5. I am told that one of your officers informed Mr. Santosh Bharati that the payment for 2008 was made late and that this had to be redressed.


6. **I have therefore to request you to let me know how this can be redressed, as I am normally not at the premises at which ETL is supposed to function.**
7. This is because, as explained above, and as informed to your officers in 2008, ETL has made huge losses, and has not done any business since 2006. It has no income and no employees. I work as the consulting editor of Forbes-India and a columnist with DNA and am hence traveling most of the time on journalistic assignments. Thus the premises are usually locked and there is no one to meet any visitor.
8. To substantiate that the company has no income (hence no business) and no employees, I am attaching relevant portions of our annual report for the past two years years for your perusal and records. The same can also be verified from the Registrar of Companies where such records are available for public reference.
9. In view of the fact that no business is transacted at ETL, I have to also **request you to cancel ETL's name from the list of establishments registered with your office.** In any case, ETL shall be requesting the Registrar of Companies to cancel its registration thus ceasing to exist by the end of 2011. In any case, all payments to your office have been made till 2012. Please advise me of the formalities to be completed in this respect.

In view of the above, I have to request you to let me know what needs to be done so that I can then request Mr.Santosh Bharati to look into the matter and complete any pending formalities.
